REPLACEMENT OF EXISTING 7,500,000 OPTIONS TO 27 DECEMBER 2009

As announced on 16 October 2007, Atlantic Gold agreed to replace CRX Investments Pty Limited's (CRX) existing 7,500,000 15 cent options expiring on 27 December 2008 with identical new options expiring 27 December 2009. This was in consideration for CRX's agreement at the time to waive its requirement for full repayment of its loans to Atlantic Gold NL from certain fundraising activities.

Atlantic Gold NL agreed to issue the new options to CRX upon the expiry of the existing ATVAO options. Please find attached Appendix 3B for the issue of 7,500,000 options exercisable at 15 cents on or before 27 December 2009.
